

## What Is Prop 65?

In 1986, California passed Proposition 65 — commonly referred to as Prop 65. It is a right-to-know law that obligates companies to include warning messages with products that contain certain substances, including substances that naturally exist in the environment. The warning message is required even if the amount of the chemical in question is naturally occurring or well below the accepted safety threshold.
